4.1 Description of first aid measures:

5.1 Extinguishing media:

Product is non-flammable under normal conditions of storage, manipulation and use, but the product contains flammable substances. 11.1 Information on toxicological effects:

The experimental information related to the toxicological properties of the product itself is not available
